REMARKS: PIL/COP RES - ALL SEARCH FAIL - J

SYNOPSIS: The Sikorsky UH34D Seahorse was a vital aircraft in Vietnam, serving as transport of both personnel and materiel. The Seahorse and its pilots particularly distinguished themselves throughout the spring of 1968 during one of the most crucial and bitterly contested struggles of the Vietnam War -- the Tet Offensive.

On March 26, 1968, a UH34D was serving as a medevac helicopter in South Vietnam. The crew consisted of the pilot and co-pilot, as well as CPL Larry E. Green, crew chief; and LCPL Ernest C. Kerr Jr., gunner. They were transported wounded Marines for medical treatment.

LTC Frankie E. Allgood had been wounded in the temple by shrapnel; LCPL Richard Evancho and CPL Glenn W. Mowrey were also injured. These three were being medevaced onboard the UH34D. The helicopter crossed a stretch of the South China Sea during adverse weather conditions. The helicopter crashed into the sea about three miles from its destination, Da Nang, South Vietnam.

Search teams were dispatched at once, and the pilot and co-pilot were rescued. Crew members Kerr and Green were not rescued, nor were the other occupants of the helicopter, including the badly wounded Frankie Allgood. All were presumed drowned and were classified Killed, Body Not Recovered. Because the medevac was apparently not struck by hostile fire, the incident was deemed non-battle related.

For the men aboard the Seahorse lost on March 26, 1968, death seems a certainty. For hundreds of others, however, simple answers are not possible. Adding to the torment of nearly 10,000 reports relating to Americans missing in Southeast Asia is the certain knowledge that some Americans who were known to be prisoners of war were not released at the end of the war. Others were suspected to be prisoners, and still others were in radio contact with would-be rescuers when last seen alive. Many were known to have survived their loss incidents, only to disappear without a trace.

The problem of Americans still missing torments not only the families of those who are missing, but the men who fought by their sides, and those in the general public who realize the full implication of leaving men unaccounted for at the end of a war.

Tragically, many authorities believe there are hundreds of Americans still alive in captivity in Southeast Asia today. What must they be thinking of us? What will our next generation say if called to fight if we are unable to bring these men home from Southeast Asia?

WASHINGTON – The U.S. Department of Veterans Affairs (VA) today announced its partnering with the [American Lung Association](#) to help Veterans, diagnosed with lung disease, live healthier lives.

The partnership will increase Veterans' access to [information about lung disease](#) and resources.

“This collaboration will promote effective coping strategies designed to slow the progression of lung disease and offer support networks to help Veterans and their caregivers,” said VA Secretary Robert Wilkie. “VA researchers are dedicated to learning more about diseases that impact both Veterans and humankind to help with prevention and treatment.”

VA and the Lung Association will also join forces on training and educational opportunities for their health care professionals to share best practices for the delivery of health care services and treatment for Veterans.

In 2018, there were more than 36 million people in the United States living with chronic obstructive pulmonary disease (COPD), asthma, and other chronic lung diseases. A [2016 study led by VA](#) found an increase in lung disease among Veterans who served in Iraq and Afghanistan. VA and the Lung Association are working to develop state of the art, evidence-based treatment for the diseases.

VA publishes federal government's first Employee Experience journey map

WASHINGTON — The U.S. Department of Veterans Affairs (VA) announced today the creation of a new, first-of-its-kind tool that supports VA's public servants in providing the highest level of service to Veterans, their families, caregivers and survivors they serve. The [Employee Experience \(EX\) journey map](#) identifies moments that are significant during an employee's career, using the same human-centered design process VA applied in the development of 45 customer journey maps to improve the experience for Veterans and their families.

"As we strive to give our Veterans, families, caregivers and survivors every reason to [Choose VA](#) for their care, benefits and services, we also want our employees to remain a part of the VA family," said VA Secretary Robert Wilkie. "Our more than 400,000 VA employees know serving Veterans is one of the most rewarding careers in federal service, and the EX journey map helps empower our workers to better serve VA customers."

The journey map is based on 11,000 insights collected from a diverse set of VA employees across 33 geographic areas. VA will use employee insights acquired from the EX journey map to also make improvements that will help the department attract top-talent, and continue to rise in "[Best Places to Work](#)" rankings among federal agencies.

VA pioneered customer journey mapping among government agencies in 2015 and leverages the human-centered design expertise to understand the pain points and bright spots for improvements to the customer experience.

Like the previously [released Customer Experience Cookbook](#), the VA EX journey map is being shared government-wide as an example to help other agencies meet their employee and customer experience goals.

Suicide prevention efforts usher promise of help for all Americans

WASHINGTON — The U.S. Department of Veterans Affairs (VA) announced today the completion of all 2020 priorities established under the [President's Roadmap to Empower Veterans and End a National Tragedy of Suicide](#) (PREVENTS) to end suicide through seamless access to care, a connected research ecosystem and robust community engagement aimed at changing the culture around mental health care and ultimately preventing suicide among Veterans and all Americans.

President Trump released the PREVENTS [roadmap](#) in June 2020 and to date, PREVENTS has accomplished [all nine priorities for the year](#), including:

- Launching [REACH](#) as a national public health campaign aimed at empowering all Americans to play a critical role in preventing suicide.
- Garnering signatures from 42 States and one U.S. Territory on a PREVENTS State Proclamation outlining agreed-upon practices and steps to engage their citizens in suicide prevention.
- Partnering with VA and the U.S. Chamber of Commerce Foundation's Hiring Our Heroes to create a Wellbeing in the Workplace Pledge and Guide to encourage companies to prioritize the mental health and wellness of their employees. More than 50 major U.S. companies and organizations have already signed the pledge.

"We have adopted a public-health approach to suicide prevention that enlists all Americans to recognize the signs of those who are vulnerable and connect them to resources that can help," said VA Secretary Robert Wilkie. "I want every Veteran to know that VA is here for you, and we will not relent in our efforts to reach those who are struggling and connect them with lifesaving support."

Achieving the 2020 milestones is fulfilled by the launch of the Suicide Prevention Grand Challenge under a partnership among PREVENTS and the VA Innovation Center in collaboration with the VA Office of Mental Health and Suicide Prevention — who will host a summit in February 2021 with experts in technology, mental health, suicide prevention and related fields to help guide the planning and implementation for the challenge.

The summit will build upon success and lessons learned from [The White House Summit on Veterans Suicide](#) held in September 2019, and guide efforts for launching, running, judging, and selecting winners of individual competitions in the Suicide Prevention Grand Challenge. VA administers over 55,000 COVID-19 vaccine doses in two weeks

WASHINGTON — The U.S. Department of Veterans Affairs (VA) announced today that it has administered initial COVID-19 vaccine doses to more than 5,000 Veterans residing in its Community Living Centers and Spinal Cord Injury and Disorders Centers and more than 50,000 health care employees in its first two weeks (Dec. 14-Dec. 27) of providing COVID-19 vaccines.

VA began vaccinating Veterans and frontline employees at [37 initial](#) VA medical centers according to its [COVID-19 Vaccine Distribution Plan](#), following the [Food and Drug Administration's Dec. 11 decision](#) to issue an Emergency Use Authorization for the Pfizer-BioNTech COVID-19 Vaccine.

The 37 initial sites to first receive the vaccine were selected based on several factors, including having the capacity to store the vaccine at extremely cold temperatures and the ability to offer high-throughput vaccination. Last week, VA announced it began COVID-19 vaccinations at [128 additional sites](#) using the Moderna and Pfizer COVID-19 vaccines. Both vaccines require two doses for maximum efficacy.

"I couldn't be happier with the work VA employees are doing in taking this important first step toward the end of the pandemic," said VA Secretary Robert Wilkie. "Successfully implementing a plan like this in the nation's largest health care system takes planning, collaboration and teamwork. As vaccines become more widely available, we will continue to implement our plan to offer them to any Veteran or employee who wants one at no cost."

Per recommendations from Centers for Disease Control and Prevention, VA will continue to vaccinate health care personnel, as well as community living center and spinal cord unit residents.

VA's ultimate goal is to offer COVID-19 vaccinations to all Veterans and employees who want to be vaccinated. As vaccine supplies increase, VA care teams will reach out to eligible Veterans to schedule vaccinations. There is no need to preregister or come to a facility to sign up.

YOU Matters. You Matter.

New Years Eve & Auld Lang Syne

The song begins by posing a rhetorical question: Is it right that old times be forgotten? The answer is generally interpreted as A Call To Remember Long-Standing Friendships...

On 31 December 1775, General Richard Montgomery was Killed-In-Action in the Battle of Quebec while fighting for a Country yet to be formed – for a Flag that had yet to ever fly. General Montgomery is considered our Country's First National Hero and his Monument at St. Paul's Chapel in New York City is our Country's First Memorial. His remains would not be returned and interred for 42+ years.

Upon learning of Montgomery's death – General George Washington would pen the following:
